RE: GREENRIDGE FARM, INC., SETTLEMENT OF UNPAID WAGES ALLEGATIONS

## YOUR IMMIGRATION STATUS DOES NOT IMPACT YOUR RIGHT TO RECEIVE PAYMENT UNDER THIS SETTLEMENT.

You are entitled to receive a payment of penalties because you worked for Greenridge Farm, Inc., at its facility located at 2355 Greenleaf Ave., Elk Grove Village, Illinois.

The Office of the Attorney General of Illinois (OAG) brought a lawsuit against Greenridge alleging that this company failed to properly pay its workers in accordance with Illinois law, including its alleged failure to pay its workers overtime wages. This lawsuit followed a joint investigation between the OAG and the United States Department of Labor Wage and Hour Division (WHD). The OAG and WHD have reached a settlement of the OAG's lawsuit against Greenridge Farm Inc. This Settlement includes the payment to you of \$<<estimated\_payment>> in owed wages and other compensation, less applicable tax withholdings. Your payment was calculated or approved by WHD and the OAG and is based on the findings of the joint OAG-WHD investigation. To receive your payment, you must fill out a Claim Form either on the website at <a href="www.GreenridgeSettlement.com">www.GreenridgeSettlement.com</a> or fill out the enclosed Claim Form and mail it back with the enclosed prepaid envelope. If you mail your Claim Form, you will receive your checks via mail at the address you provide in the form. The first deadline to complete this Claim Form is June 17, 2024. If you complete the Claim Form by that date, you will receive your first payment shortly after July 17, 2024. There will be four payments made between July 17, 2024 and November 19, 2025. You may also submit a late Claim Form up until October 20, 2025.

Your acceptance of this payment of wages and liquidated damages due under the Fair Labor Standards Act (FLSA), based on the findings of the joint OAG-WHD investigation means that you have given up the right you have to bring suit on your own behalf for the payment of such unpaid minimum wages or unpaid overtime compensation for the period of time from May 24, 2019 to May 24, 2022 and an equal amount in liquidated damages, plus attorney's fees and court costs under Section 16(b) of the FLSA.
